

My American Federal Government Executive Law Enforcement; Affidavit of Forgiveness, Pardon and Orders.

In order to **Restore** the harmonious American Governmental Republic Relationships between the true American Executive Federal Government of the People and the American Constitutional National Government Officers of this Nation, I **present** the my following **Affidavit and Pardon**.

I am stepping forward with my **Federal Government Executive Law Enforcement "Pardoning Power" of the People**, per the American Executive Commandment known as the **10th Amendment**; to **Grant a full pardon, forgiveness and reconciliation** to the National Government Officers for their Republic Misconducts and Foreign "BAR" Involvements; that are willing to **Renounce** their **Foreign Commercial STATE "BAR" complicities** and **Reinstate** themselves as a **Condonation** back to the **valid Laws of the National and State Republic Constitutions**.

IF NOT ACCEPTED, the National Government Officers "Bailment Bonds" will be Ordered to be Arrested by this **Federal Government Executive Law Enforcement – Bounty Hunter** for the **10% of the Posted "Bail Bond" Reward** and further prosecuted, as I am also a **Federal Government Executive Law Enforcement – Private Attorney General**, to stand in any Republic National Constitutional Article 3, "Non-Commercial – Foreign BAR" court, for the additional "Bail Bond" Reward and 50% of all other fines and insure the additional penalties as justly adjudicated.

I further stand with my **Federal Government People Powers** per the American Peoples' Executive Commandment known as the **10th Amendment**; to **DECLARE** the "**Amendments 16 thru the 27**" to be **INVALID**, as they have **infringed** upon the **Lawful and Valid Executive Peoples Powers and Rights** as they are addressed within the first 15 American Peoples Executive Amendments "Commandments". Per the Universal Laws, an enacted Law cannot be overruled by a new law, the original has to be first be removed (*as the case of the Original 13th which was removed, because it infringed upon the 9th and 10th Amendments when it was finally properly adjudicated*) or changed and this is present case of the 16th thru the 27th amendments which are infringements and need to be properly Adjudicated based upon the Universal Laws.

Therefore, the Original 15 Amendments are the only standing Valid Constitutional Amendments, as the Peoples Federal Government Executive Commandments and I am by my **Federal Government Executive Authority, Ordering and Commanding** the **Males** on the **National Republic Supreme Court** in their Non-Commercial Foreign "BAR" capacity to make the **Validity Ruling** on the 16th thru the 27th amendments per the Law, of which has not been done to this present date.

COMPLICITY: *The state or condition of a person, who is involved as an accomplice.*

PARDONING POWER: *The power to grant pardons; an executive power, as it usually exists, but a power within the control of the People and to be conferred by them upon such officer or officers as they see fit. 39 Am J1st Pard § 12.*

FORGIVENESS: *See condonation; reconciliation.*

CONDONABLE OFFENSE: *A single act or series of acts of Misconduct constituting a ground for divorce which in theory may be forgotten or Forgiven, or a species of misconduct which considerate and affectionate treatment might serve to obliterate. 24 Am J2d Div & S § 204.*

CONDONATION: *The Forgiveness, either express or implied, by a husband of his wife, or by a wife of her husband, of a breach of marital duty, with an implied condition that the offense Shall Not be repeated. 24 Am J2d Div & S § 204.*
